Have bargained and sold, and by these presents do bargain and sell and in plain  
and open market deliver to the Beverly Borroum the following property, to wit, one  
dark bay Horse about sixteen years old about 14<sup>h</sup> hands high has three white  
feet and glass eyes, one horse cart and pair of gears one bed bedstead & furniture  
one pot, one oven, one Skillet, one trunk, one chest, one table, one axe, two hoes, one plough  
and a small quantity of Corn and fodder, two pails, two piggins, one wash Tub, one  
grid Iron, one cotton wheel and cards & one looking glass, To Have and To Hold  
all and singular the aforesaid property unto the said Beverly Borroum his Executors admini-  
strators and assigns forever, Provided Nevertheless that if the said William Bray his heirs  
Executor or administrator shall and do well and truly pay, or cause to be paid unto the  
said Beverly Borroum his certain attorney his heirs Executors administrators or assigns  
the full and just sum of Thirty four Dollars 75<sup>cts</sup> with Lawful Interest thereon
