This Indenture made this twenty fourth day of August in the year of our Lord one thousand seven hundred and seventy six between John Cyle Senior of the county of Pendleton & State of South Carolina of the one part & Laurence Brasher of the county of Greenville State aforesaid of the other part -

Witnesseth that he said John Cyle jun. for and in consideration of the sum of one hundred pound to him in hand paid by said Laurence Brasher before the delivery of these presents the receipt is hereby acknowledged Have sold and confirmed and by these presents doth grant bargain sell and confirm unto the said Laurence Brasher his heirs and assigns forever two hundred acres of land more or less being part of a tract of six hundred and forty acres of Land surveyed for Samuel Cyle the 31<sup>st</sup> day of January 1785. & originally granted to Francis Breemar & Peter Francau by their excellency William Moultrie & dated thirde day of April one thousand seven hundred and eighty six & conveyed to John Cyle Sen. by Francis Breemar & Peter Francau for the use of the children of said Cyle deceased and from John Cyle Sen. conveyed to John Cyle Junior one of the children of said Cyle Deceased, it being a part of a tract as aforesaid containing two hundred acres of Land more or less lying & being as aforesaid Beginning at a stake on Stony creek thence running S. 60. W. to a black oak thence S. 30 E. 45 Ch. to a black oak thence S. 50 W. to Needy River runs on the original line from said Stony creek to Needy River thence up said River to Stony creek thence up said creek to the Beginning corner, including all the lands and tenements in said Boundary with the water of said River and creek to the middle of each as will appear by a plat annexed to the aforesaid Grant & recorded in grant book B. A. 5 Page 8 reference being had thereto with more fully appeared Together with all houses out houses gardens orchards edifices building woods fences waters water courses Millages Profits hereditaments <sup>rights incidents</sup> and appurtenances to the same belonging & every part & parcel thereof - & all the estate right title Interest claim and demand whatsoever unto the said Laurence Brasher (his heirs
