The State of South Carolina, Greenville District, Know all men by these presents that that Samuel Roberts of the state and district aforesaid for and in consideration of the sum of one hundred Dollars to me paid by Samuel Williams of the state and district aforesaid, Have granted bargained sold and Released, and by these presents do grant bargain sell and Release unto the said Samuel Williams a certain tract of land containing Eighty two acres more or less situate in the district aforesaid lying on the Rocky fork of Golden Grove Creek it being part of a tract of land granted to John Waldrop and bounded as follows (Viz) Beginning at a black oak sapling by a pine stump, and running thence N. 37 E. 39 chains to a post oak, thence S. 70. E. twenty two Chain to a post oak thence S. 25 W. twelve chain to a black oak, thence S. 35 W. along a road Eighteen chains to a black oak thence S. 85 W. & N. 86 W. & N. 80 W. continued on the Road to the Beginning. Together with all and singular the rights members here ditomons and appurtenances to the said premises belonging or in any wise incident or appertaining. To Have and To Hold all and singular the premises before mentioned unto the said Samuel Williams his heirs and assigns forever, And I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Samuel Williams his heirs and assigns against myself my heirs and assigns & against every other Person and Persons whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this tenth day of June in the year of our lord one thousand eight hundred and in the thirtieth year of the independence of the United States of America signed & delivered in presence of Peter Pinnett
