Know all men by these presents that I William Harbin of Greenville District in the State aforesaid for and in consideration of two hundred dollars to me in hand paid by Abner Smith of the State and district aforesaid I have granted bargained and sold and by these presents do grant bargain and sell unto Abner Smith his heirs and assigns forever all that tract or parcel of land containing two hundred & thirty acres, situated in the State and district aforesaid, on the south side of Rocky creek water of Enoree River Beginning on a red oak corner on Blagrove Glenny line on the south Bank of said Creek running S. 7 E. 21.50 to a stake then S. 23 W. 21.50 to a post oak 3^t then S. 07 W. 32.50 to a red oak 3^t then N. 80 W. 15.50 to a Black jack 3^t then N. 10 W. 43.75 to said creek again then down the meanders of said creek to the Beginning, which include the full land to be conveyed together with all singular the rights, members, hereditaments and appurtenances to the said premises, belonging or in any wise incident or appertaining thereto to the only proper use & benefit of him the said Abner Smith his heirs & assigns, forever, Said William Harbin doth hereby bind himself his heirs Executors and administrators to warrant & forever defend all and singular the premises, above mentioned unto the said Abner Smith his heirs Executors & assigns forever against myself my heirs Executors and administrators and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
