


250. Station. Bounded by lines running N.E. by Joseph Thompsons north

belonging or in any wise incident To have & to hold ~~the~~ said tract of  
Fifty two acres of Land & all singular the said premises hereby granted unto  
the said William Ponder his heirs & assigns forever, and I do hereby bind my  
self my heirs Exr. and administrators to warrant & forever defend all &  
singular the premises before mentioned unto the said William Ponder  
his heirs & assigns from any person or persons claiming or lawfully claiming  
the same or any part thereof. In witness whereof I have hereunto set hand  
and seal this fifth day of January one Thousand Hundred thirteen and  
in the XXXVII year of American Independence in presence of us.

Edwards of Greenville District & State aforesaid in consideration of the sum  
of Fifty <sup>two</sup> Dollars to me in hand paid by William Ford of the State and  
District aforesaid the receipt of which is hereby acknowledged have granted  
bargain<sup>d</sup> sold released convey<sup>d</sup> & confirm<sup>d</sup> ~~to the~~ & by these presents do  
grant, bargain, sell, release convey & confirm unto the S. D. Wm Ford his  
heirs & assigns a tract or parcel of Land containing Thirty acres (by estimation  
be the same more or less, situate in Greenville District aforesaid on the branches  
of the North Fork of Saluda River & runs as follows that is to say Beginning  
on a stake where Stanfords line crosses a small branch that runs through Wm  
Shectors field thence up sd. <sup>branch</sup> to the fork thereof thence up the west or Left hand fork  
to the head, in an old field; thence up the hole out North westerly course to a stake  
on the ridge thence nearly the same course down a hole out through the old  
field to the head of a small branch that heads in the hollow thence down  
said branch to a conditional line mark<sup>d</sup> between Marsden & Albert J. Smith  
son thence with a conditional to a sowerwood corner, or near Salmon  
thence with sd. line a southerly course to a large chestnut thence with a conditional  
line to a ~~spanish~~ spanish oak near John Shectors field thence with sd. conditional  
marked line to Stanford line thence with Stanfords line to the Beginning  
being part of Large survey granted to Rott. Prince by grant bearing date the  
seventh day of March one Thousand seven Hundred and Eighty seven  
together with all and singular the rights members hereditaments and
