

bookery of the State and District aforesaid in consideration of ~~the sum~~ of Two
hundred ^{Dollars} to me in hand paid by Joshua Hawkins of the District aforesaid have
granted sold and released and by these presents do grant bargain sell and release
unto Joshua Hawkins all that plantation or tract of Land where I now live
containing One Hundred acres be the same more or less Situate lying and being
in the District aforesaid on the branches of Satuda River being part of a
tract originally granted to Samuel French and this part conveyed to me by the
-sth French on the 10th day of January 1794 Beginning on a rock forty
rod from the original corner on a pine running thence to a white oak
corner made on the conditional line thence to the dog wood corner
at the shoal on a branch thence down said branch to Thomas Carret line
thence a south course to a black oak corner, thence a direct line to the big
-ing corner on the Rock, Together with all & singular the rights members
hereditaments and appurtenances to the said premises belonging or in any
wise incident or appertaining To have and to hold all and singular the premi-
-ses before mentioned unto the said Joshua Hawkins his heirs & assigns forever
and hereby bind myself my heirs Executors & administrators to warrant and forever
defend all and singular the said premises unto the said Joshua Hawkins his heirs
and assigns against myself my heirs and against every other person who may
-ver Lawfully claiming or to claim the same or any part thereof, witness my
hand and seal this Twenty Eighth of September in the Year of our
134
