Know all men by these presents that I Charles Pope of the district of Greenville and State aforesaid have granted bargained sold and released, and by these presents do grant bargain sell and release unto Blake Galton a tract of land containing two hundred and twenty acres more or less, lying in Greenville district, on Baker Creek on both sides of the same, being part of a tract of land originally granted to Charles Pope, by his excellency the 16<sup>th</sup> Nov. on the 5<sup>th</sup> day of July 1794. and part of a tract of land granted to Robert G. Ullam by his excellency The Pinckney on the seventh day of April 1788, as by the Plat annexed to the grants will more fully appear, being laid out unto said Blake Galton as follows; Beginning on a black Jack Corner, thence running S. W. 28. Eighteen chains, to a small red Oak Corner thence running S. E. 75. and 13 chain, to a Post Oak corner, thence running S. E. 22 - 14 chains, to a Post Oak Corner, thence running N. E. ward to a Post Oak Corner, thence bounding on a part of the said land laid out to James Hutton to a red Oak on the original line, thence N. W. to a Stake Corner thence E. ward to a poplar corner on the south side of the said Creek, thence running up the said Creek to a Hickory Corner on the North side of S. Creek, thence running a straight line to intersect George Piques line, ten chains on the north side of the S. George Piques Spring branch - the said Piques line is the original line, thence running along the original line S 28 W. to a Post Oak corner on William Dalys line, thence S. 62 W. to the beginning - to include two hundred and twenty acres of Land more or less - Together with all and singular the right, members, hereditaments, and appurtenances, to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Blake Galton his heirs and assigns forever. And I do hereby bind myself my heirs, executors, and administrators to warrant & forever defend all and singular the premises unto the said Blake Galton his heirs & assigns against myself my heirs & assigns, and all and every other person or persons whatsoever.
