fifty dollars to me in hand paid by Stephen Patten of Greenville district in the State aforesaid
hath granted bargained sold and released unto the said Stephen Patten one certain tract
of land containing one hundred and sixty four acres, more or less, Situate lying and
being in Greenville district on the East side of Saluda river in the State aforesaid, being
part of a tract of land originally granted to Robt Gilliland, and signed by his excellency
William Moultrie Esq^r the then Governor on the 5th day of December in the year of 1785.
and recorded in grant book G.G.G.G. page 280 and afterward conveyed by said Gilliland
to William Pogue and from said Pogue to Nathan Waddell. Beginning on a Post oak on John
Bowie's line, thence along the original line to where it intersects a line originally run for David
Sentry now occupied by Barksdale Garrison, thence along the old line, thence to the
line of a tract of land laid out for Alexander Gilliland, thence along the original line to a
black oak being a condition line from thence a direct line to the beginning corner, but
still a conditional line. Together with all and singular the rights, numbers, headements
and appurtenances, to the said premises, belonging or in any wise incident or appertaining to have
and to hold, are and singular the premises, before mentioned unto the said Stephen Patten his heirs &
assigns forever. And I do hereby bind myself, my heirs executors and administrators, to warrant
and forever defend all and singular the said premises, unto the said Stephen Patten his heirs &
assigns against myself and my heirs and all other persons lawfully claiming or to claim all or any

20 ch. 50 link to a small black ~~red~~ gum thence N. 87 E 30 ch. to a locust Stake, thence N. 32 E till
it intersect s^t Woods old line, on a channel corner of said Woods old tract, the s^t Chestnut
