





Know all men by these presents that I William Gambling of Greenville District and State aforesaid, for and in consideration of the sum of two hundred dollars to me in hand paid, by Israel Fowler of the district and State aforesaid, have granted bargained and sold and released and by these presents do grant bargain sell and release unto the said Israel Fowler & certain tract of land lying and being situated in the district and State aforesaid on the bridge fork of Guilders Creek, beginning at a Black Oak below the Plantation, and running N.W. to a Pine, thence West to a Pine, S. by a Conditional line, bounded by Eargan to the original line to the said tract and down the old road to the Creek, and thence down the said Creek to the beginning, including One hundred and Sixty acres, be the same more or less, Together with all and singular the rights & members hereditaments and appurtenances to the said premises, belonging or in any wise incident or appertaining, To have and to hold all and singular premises before mentioned unto the said Israel Fowler his heirs and assigns forever. And I do hereby bind myself my heirs and executors and administrators to Warrant and for ever defend all and singular the said premises unto the said Israel Fowler his heirs and assigns against myself and my heirs, & against every other person whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this 12th day of January 1803.







Know all men by these Presents that I Richard Hall of the District of Greenville & State of South Carolina for and in consideration of one hundred and fifty dollars to me in hand paid by Loving Ross of the district and State aforesaid, the receipt whereof is hereby acknowledged and myself perfectly satisfied therewith, contracted and paid, hath bargained sold and delivered, and by these presents doth bargain sell and deliver unto said Loving Ross a Negro Girl named Lucinda, about five years of age, which negro girl and her increase I do hereby warrant the right and property of unto the said Loving Ross his heirs and assigns forever — from myself, my heirs & from the lawful claim or demand of all & every other person or persons whomsoever. In Witness whereof I have hereunto set my hand and seal this 12th day of November 1814.
