And we do here by bind ourselves our heirs executors & administrators to warrant and forever defend all and singular the premises before mentioned unto the said Rowland Tarrant his heirs and assigns, against ourselves and heirs forever. Know all men by these Presents that Rowland Tarrant of Greenville District in the State aforesaid for and in consideration of the sum of Nine Hundred dollars to me in hand paid by John Blasingame of the said district, I have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said John Blasingame, All that plantation or Tract of Land situate lying and being in the aforesaid district, on the Western side of Mill branch, of the Golden Grove Creek, containing two hundred and forty five and one half acres, more or less, Beginning on a Stone Corner, at S. branch joining North West forty five - 52, 75 to a Stake, thence N.E. 44 - 26, 75 to a hickory tree N.E. 58 - 11, 80 to a Poplar, then N.E. 48 - 18, 70 to a red Oak, thence S.E. 45 - 31, 70 to a Stake on said branch then down said branch with its meanderings to the beginning, cutting and bounding on the North East on lands of John Charles North West on lands of Julius Huff - South West on lands of the Estate of John Tarrant
