which I have and do bear to my son in Law Thomas Goldsmith of the
district and State aforesaid have given & granted and by these presents
do give and grant unto the said Thomas Goldsmith his heirs executors
or administrators, all the tract of land whereon I now live containing
Two hundred and fifty three acres it being a part of a tract of land
conveyed to Henry Cook by William Lacy the grant bearing date the
first day of June 1788. granted to Nath. Reid and conveyed to William
Lacy beginning at a Red oak and running N. 20 W. 97 Chains to a Spanish
oak thence S. 45 W. 27 C. to a Spanish oak thence S. 20 E. to a Stake thence
N. 82 E. to the beginning which includes the whole land to be conveyed
To Have & To Hold all the above mentioned premises together with all my
stock that is to say horses Cattle sheep & Hogs viz two head of horses four
head of Cattle four head of sheep Eleven hogs to him the said Thomas
Goldsmith his heirs executors or administrators from hence forth to Have
