that he saw John Patterson sign seal and deliver the within
deed of conveyance to George Gorman for the purpose therein
mentioned and that Tho. Carrasmith was a subscribing witness
with himself sworn to and subscribed before me this 21st day

I Eli Baldwin of the district and State aforesaid for and in consideration
of one hundred dollar, to me in hand paid by Jesse Robins of the district
and State aforesaid, have granted bargained sold and released and by
these presents do grant bargain sell and release unto the said Jesse
Robins a plantation tract or parcel of land lying in the district
aforesaid and on the waters of Reedy River containing by estimation
one hundred acres more or less and bounded as followeth to wit,
cornering on the market road on lands laid out to John P. Bonnett
S.W. to a black jack corner S.E. to a post oak corner on Brasley land
S.W. to a red oak corner S.E. on lands laid out to William Haden to
a post oak corner N.E. on lands laid out to William Bonds to a post
oak corner thence N.E. on lands laid out to William Gilham to a
Red oak corner, N.E. to the market road cornering on said road and
running with said road to the Beginning — it being part of a tract origin-
ally granted to Samuel Pollock being a part of 232 acres & Schaggs
by His Excellency William Moultrie on the 4th day of September 1786
and has been conveyed down through different hands to the said
Eli Baldwin. — Together with all and singular the rights members
Instruments and hereditaments and appurtenances to the said premises
belonging or in any wise incident or appertaining. To have & To hold
all and singular the premises before mentioned unto the said Jesse
Robins his heirs and assigns forever and I do hereby bind myself my
heirs &c. to warrant and forever defend the right and title of the
above land to the said Jesse Robins free from the claim of myself
my heirs &c. — In Witness whereof I have hereunto set my hand &
seal this the 11th day of March 1815. signed sealed and delivered
in the presence of us Justs. — { Eli Baldwin Seal
