 Sum of Six hundred dollars to me in hand paid by Thomas Wingo of Spartanburg
 District and State aforesaid have granted bargained sold & released & by these
 presents do grant bargain sell and release unto the said Thos. Wingo all those
 Several tracts or parcels of land lying & being in the District of Greenville
 on the waters of Brushy Creek & Ennore River one tract or parcel of land con-
 taining Two hundred and ninety nine acres more or less conveyed from Joseph
 Edwards to me beginning on a Spanish Oak on the waggon road leading from Green-
 ville Co. to Spartanburg Co. & running thence N. 20 E. 61.25 to a black oak
 thence N. 75 W. 50 to a post oak on Henry Benson's line thence
 N. 26 E. 19 to a black oak on Benson's line thence N. 60 E. 9.50 to a black oak on
 Benson's line thence S. 45 E. 41.50 to a Stake on Johnson's line thence a long
 straight line S. 73 W. 32 to the waggon Road thence with the mainders of the Road
 to the beginning also one other tract or parcel of land adjoining the above
 containing Ten acres more or less conveyed from Thomas Kemp to me begin-
 ning on a Stake on Joseph McAfee's line running thence S. 47 W. 22.60
 to a Stake thence S. 43 E. on said line so far as will include Ten acres with a straight
 line to McAfee's line = also one other tract or parcel of land adjoining the above tract
 containing five acres more or less conveyed from Josef Klauhn to me beginning on a Stake
 in the road on Normans line running S. 61 W. 5 chains to a post oak thence N. 80 W. 11 chain
 25 links to a Stake by a red oak thence N. 10 E. 5 chain to a hickory on the edge of the
 road thence with the Road to the beginning = also one other tract or parcel of land ad-

 hickory running thence S. 40 W. 40 to a Stake thence N. 20 E. 21.50 to a post oak thence
 N. 10 E. 11 to a Stake thence S. 83 E. 20 running with the road leading from Greenville to Spartanburg
 Co. House to the beginning containing in the whole Three hundred & forty four acres more or less
 together with all and singular the right to members hereditaments & appurtenances to the said premises
 belonging or in any wise incident or appertaining to have and to hold all and singular
 the premises before mentioned unto the S. Thomas Wingo his heir & assigns forever
 & I do hereby bind myself my heirs Executors and administrators to warrant & forever
 defend all and singular the said premises unto the said Thomas Wingo his heirs & assigns
