 Released & by these presents do Grant bargain sell & release unto  
 the said David Masteller all that tract or parcel of land containing  
 one Hundred & fifty Acres be the same more or less situate on both  
 sides of the South fork of Tiger river being part of a tract of land  
 known by the name of Millport in the same District beginning at  
 an oak Charles Galeshly's corner & running up the said River & on  
 the north side to a water oak corner also on the river bank thence  
 crossing said river to a Maple corner to Eye Pectors thence S. 25 E. 12  
 Ch 50 1/2 to a post oak S. 55 W. crossing the Great road & crossing  
 -ch 10 Ch 50 links to a post oak corner on Rectors line N. 2 E. crossing  
 the river S. Ch 50 1/2 to a bunch corner N. 5 E. 7 Ch 50 links through a field  
 to a white oak corner in a line N. 75 W. along the lane 3 Ch to a white  
 corner N. 8 E. 1 Ch 40 1/2 poplar stump on the upper edge of the

 & we do hereby bind ourselves our heirs Executors & Administrators  
 to warrant & defend all & singular the said premises unto the
