 the north side to a Water Oak corner also on the river bank then
 crossing said river to a Maple corner to ye Reckers thence S. 26 E 12
 62 56 9 1/4 to a post oak S. 55 W. crossing the Great road & a spring line
 in 19 6h 50 links to a post oak corner on Rector's line N. 52 8 1/2 E crossing
 the river 6h 50 1/4 to a bunch corner N. 56 7 6h 50 links through a field
 to a White Oak corner in a line N. 75 W. along the lane 36h to a Patti
 corner N. 8 E 16h 40 1/4 poplar stump on the upper edge of the

 claim or to claim the same or any part thereof witness our hands
 and seals this twenty second day of August in the year of our Lord
 One thousand Eight hundred & seventeen & in the forty second year of
