


It follows beginning upon a heckerly on the old line thence to the head of a branch thence down the Meanders of said branch to Red river thence down thence down the Meian Stream to Robert Duncans Maple Corner Eastwardly course a conditional line to Charles Bensons old Original line thence up the said line to a post Oak Corner then taking a long John Harrisons old line to a heckerly corner the beginning bounded by Charles Benson by Robert Duncans George Brock and Hudson Staten & Nimrod Underwood Together with all & singular the rights Members Hereditaments & Appurtenances to the said premises belonging or in any wise incident or appertaining to have & to hold all & singular the said premises unto the said George Underwood his heirs & assigns forever & I do hereby bind my self my heirs Executors & Administrators to Warrant & forever defend all & singular the said premises unto the said George Underwood his heirs & assigns against my self & my heirs & against Every person Whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand & Seal this 21 day April 1857 A.D.
