 Daniel Wrights land S 60 W. John Williams S 41 W. S 20 W on  
 Stephen Howard S 45 E. S 45 E. on Nicholas Davies land S 45  
 E on Banister Stones land. And hath such form & marks as  
 shall hereunto annexed doth represent being part of Seven hundred  
 & fifty three acres Originally granted to Nicholas White 17<sup>th</sup> day  
 of April 1793 Together with all & singular the rights members and  
 Appertaining to the said premises or in any wise belonging to have  
 & to hold and singular the premises before mentioned unto the said  
 James Kilgore his heirs & assigns for ever & I do hereby bind my  
 self my heirs Exec<sup>r</sup> & Adm<sup>r</sup> to warrant and forever defend the
