N<sup>o</sup> 16 West 200 feet to a stake thence S<sup>o</sup> 74 West 200 feet to a stake then N<sup>o</sup> 16 E. 200 feet to a stake then S<sup>o</sup> 74 East 200 feet to the beginning; Together with all & singular the rights members hereditaments & appurtenances therunto belonging or in any wise appertaining; to have & to hold the above mentioned premises and And I the said Vardry M'Beel for my self my heirs Executors or Administrators do hereby warrant & defend the above mentioned premises to the said Hardy Fennel his heirs or assigns forever, against my self my heirs, & against every person lawfully claiming the same or any part thereof.
