- sell & release unto the s<sup>r</sup>. Archable McDonald a plantation & part of a tract  
of land that was originally granted to John Reed lying in the stat & district  
aforesaid on the waters of Mountain Creek beginning on a post oak 3 x three  
- running a westward by course on a straight line to a red oak 3 x  
three a southward course on Woods line to a conditional pine corner  
3 x three a straight line a North East course to the beginning corner  
- lying on John McDonald land including the plantation where  
said Archable McDonald now lives with seventy five acres of land  
to the same more or less together with all and a singular the rights  
members hereditaments & appurtenance to the said premises belong-  
- ing or in any incident or appertaining to have & to hold all  
and a singular the premises above mentioned unto the s<sup>r</sup>. Archable  
McDonald his heirs and assigns forever And I do hereby bind myself  
my heirs Executors & Administrators to warrant & defend all and  
singular the said premises unto the s<sup>r</sup>. Archable McDonald his heirs  
& assigns against myself & my heirs & against Every other person who-  
- soever lawfully claiming or to claim the same or any part thereof  
Witness my hand and seal this fifth day of February in the year of  
our Lord one thousand eight hundred & fourteen & in the thirty eight  
year of the Independence of the united states of America signed sealed  
and delivered in the presence of, Uniah Slaton } John McDonald  
Hewell Sullivan, Drury Morris }
