 N. E. on land laid out to Job Charles J. E. on a ridge over all on the da Indian
 line & hath such shape & form as laid down in a plat annexed to the original
 grant. Together with all & singular the rights, members, hereditaments & appurtenances
 to the said premises belonging or in anywise incident or appertaining To have & to hold
 all & singular the premises before mentioned unto the said David Trauurn
 his heirs & assigns forever. And I do hereby bind myself, my heirs, Exors & Amors
 to warrant and defend all and singular the s^d premises unto the s^d David
 Trauurn his heirs & assigns against myself & my heirs & against every other person
 whomsoever lawfully claiming or to claim the same or any part thereof. Witness
 my hand & seal this twenty second day of May in the year of our Lord one
 thousand eight hundred & eighteen & the forty second year of the Independence of
