


Know all men by these presents, that I Land Fowler of the district of Spartanburg & State aforesaid in considera- tion, of the sum of two hundred dollars, to me paid by W^m Holcombe of the district of Greenville & State aforesaid. have granted bargained sold & advanced & by these presents do grant bargain sell & release unto the sd W^m Holcombe all that tract or parcel of land situate in the dist. of Greenville on both sides of Vaughan's Creek beginning at a hickory running thence N 44 ch^{ts}: 40 ch^{ts} to and oak thence W 27 ch^{ts}: to a chestnut thence S 44 ch^{ts}: 40 ch^{ts}: to a pine thence E 27 ch^{ts}: to the beginning containing one hundred & sixteen acre, more or less it being granted to me by patent bearing date the 21st day of January one thousand seven hundred & eighty five. Together with all & singular the rights, number, hereditaments, & appurtenances, to the premises belong- ing, or in any wise incident or appertaining. To have & to hold all and singular the premises before mentioned unto the sd W^m Holcombe his heirs & assigns forever. and I do hereby bind myself my heirs, Executors or Admors to warrant & forever defend all & singular the premises before mentioned unto the said W^m Holcombe his heirs, & assigns against myself my heirs, Executors or Admors & against all & singular the claims of Every other person a person, whom, own lawfully claiming or to claim the same or any part thereof.
