Have granted, bargained, sold & released, and by these presents do grant, bargain, sell & release unto the said Joseph McCollough all that plantation or tract of land containing forty eight acres, (more or less) situate in the district aforesaid lying on harridan creek water of Saluda river. Beginning on a white oak stake & bounding thence S 85 W 18:50 to a stake & bounding on Charles Est. Sec. thence S 9 W 13 to a rock & in a hanch thence down the meander of said hanch S 53 E 9 to a red oak stake at its confluence with harridan creek thence down said creek 4:50 to a willow stake thence N 52 E 31:50 to a rock stake thence N 78 E 7:50 to a stake & one hanch thence down the meander of said hanch to the beginning. Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any way incident or appertaining. To have & to hold all & singular the premises before mentioned unto the said Joseph McCollough his heirs & assigns forever. And we do hereby bind our selves our heirs Executors and administrators to warrant & defend and all & singular the said premises unto the said Joseph McCollough his heirs & assigns against ourselves and our heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof. Witness our hands and seals this 22<sup>d</sup> day of January in the year of our Lord 1820, and in the 44<sup>th</sup> year of the Independance of the United States of America.
