



Singular the premises before mentioned unto the said ¹⁸⁰

 of the sum of twenty dollars to me in hand paid by Wm Lankford
 of the state and district aforesaid, have bargained sold & released
 and by these presents do grant bargain sell & release unto the said
 Wm Lankford all that tract or parcel of land being in the
 district of Sumwill on the S^o side of S^o side of S^o side river. Beginning
 on a hickory on the original line thence on a conditional line
 made between said Swafford and said Lankford to a stone
 corner on the river bank thence down the river to a stone corner
 on the bank of the river on the original line thence along the
 said line to the beginning corner. Containing two acres more
 or less the same being a part of land the said Swafford now
 together with all and singular the rights members, heirs &
 remedies to the said land belonging or in anywise appertaining
 To have and to hold all & singular the said premises before
 mentioned unto the said Wm Lankford his heirs & assigns
 forever and I do hereby bind myself my heirs Exec^r & adm^r to
 warrant and foun defend all and singular the said premises
 to the said Wm Lankford his heirs & assigns against myself
 my heirs & every person whatsoever claiming or to claim the
 same or any part thereof. In witness whereof I have hereunto
 set my hand and seal this thirtieth day of Sept^r one thousand
