State of South Carolina. Know all men by these presents, that I Benjamin Bruce of Greenville district in the state aforesaid in consideration of  
three hundred dollars to me paid by Aaron Stump of the district & state  
aforesd. Have granted, bargained, sold & released & by these presents do grant  
bargain, sell & release unto the said Aaron Stump a certain plantation  
or tract of land containing three hundred acres more or less lying  
in the district and state aforesaid on the N<sup>o</sup> side of Enore & on the S<sup>o</sup>E<sup>t</sup>.  
side of a branch called the long branch on the upper limb of s<sup>o</sup> tract  
Whereas it beginning on a pine thence running S<sup>o</sup>E<sup>t</sup>. course with a  
stake line to a black oak corner thence to a stake corner on  
Bridewells land thence with Bridewells line S<sup>o</sup> 30 W to Sanders line  
thence with Sanders line to a corner corner on the upper limb of s<sup>o</sup> tract  
thence with the old line to the beginning. Together with all  
and singular the rights, members, hereditaments & appurtenances  
to the said premises belonging or in any wise incident or appertaining  
to have & to hold all & singular the premises before mentioned unto the  
said Aaron Stump his heirs and assigns forever and I do hereby bind  
myself my heirs Exec & Adm<sup>rs</sup> to warrant & forever defend all and  
singular the said premises unto the said Aaron Stump his heirs  
and assigns against myself & my heirs & against every person  
whosoever lawfully claiming or to claim the same or any part there  
of. Witness my hand & seal this 27<sup>th</sup> day of April in the year of our Lord  
1812. and in the 36<sup>th</sup> year of the Independence of the United States of America  
intertined before signed with the words "whereas it beginning on a pine".
