 district aforesaid on the East Side of the Sinkhole fork of Tyger  
 River beginning on a large sweet Gum Standing on the west  
 bank of S. Creek. Thence running North fifty four East three Chains  
 to a willow on the bank of a branch thence up the various meanders  
 of Saia branch about one hundred and Sixty yards to a Hickory  
 Jonathan Stokes' Conditional Corner. thence South fourteen East  
 nine Chains fifty links to a Chestnut, thence South Seventy four  
 West, with the Cross fence made by Sterling Harris to the mouth  
 of the Saia branch, above mentioned thence up the meanders of  
 Saia Creek to the beginning Corner a large Sweet gum supposed  
 to contain two & a half Acres be the Same more or less it being a  
 part of a Survey of land conveyed to John Gowen dec'd by Edm'd  
 Bearson, and by his last will bequeathed the said <sup>land</sup> to his son
