aforesaid have granted bargained sold & released & by these presents do grant
bargain sell & release unto the said Robert Peden a plantation or tract of
land laying in the State & district aforesaid on the South side of the South fork
of Tabernas Creek water of Nease River it being part of a tract of land
originally granted to Cornelius M. Mathis beginning at an acre 3x
on the bank of said Tabernas Creek then running N. 14 W. 11.40 to a red
oak 3x then N. 85 W. 29. to a Chestnut 3x bounded by William M. Mathis
land then south on the old Indian boundary lines 41. to a Stake 3x &
bounded on said Robert Peden's land, then east 20. to the Creek & bounded
on Jane Kellert's land, thence up the main creek of said Creek to the
beginning including the house & plantation where Venice Corbin
now lives with Ninety five acres of land be the same more or less
Together with all & singular the rights members hereditaments and
appurtenances to the said premises belonging or in anywise imme-
diately or appertaining to have & to hold all & singular the premises
before mentioned unto the said Robert Peden his heirs & assigns
forever & I do hereby bind myself my heirs executors & administra-
