

State of South Carolina, Greenville District, To now all men by  
 These presents that I, Thomas Long senior, of the District & State aforesaid  
 For and in consideration of the sum of twenty Dollars, to me in hand  
 paid by Isaac Cox of the District and State aforesaid have granted  
 Bargained sold and released and by these presents do grant Bargain  
 and sell unto the said Isaac Cox, a plantation or tract of land ly-  
 ing and being, situate in the District, and State, aforesaid, the land  
 To be conveyed begining on a pine corner on the sd. Thomas Long  
 Line thence along sd. line 44 1/2 chains to sd. Coxes line thence along  
 sd. line 43. Chains to a stone corner on Coxes line thence along  
 Jacob Blackes line 14 1/2 chains to a Dogwood corner on sd. Blackes  
 line thence a strait line to the begining corner, In cluding fift-  
 en acres of land more or less together with all & singular the rights  
 members, hereditaments & appurtenances to the sd. premises belo-  
 nging or in any wise appertaining to have & to hold all and sin-  
 gular the premises before mentioned unto the sd. Isaac Cox his heirs  
 and assigns forever, and I do, here by bind myself my heirs Executors  
 and administrators and assigns to warrant & forever defend, all  
 & singular, the premises before mentioned unto the said Isaac Cox,  
 his heirs and assigns forever, against myself & my heirs & every  
 other person whomsoever, claiming the same or any part thereof  
 of my witness, whereof I have, unto set my hand & seal this 10<sup>th</sup>  
 Day of April in the year of our Lord one thousand Eight hundred  
 and twenty four, signed and delivered in presents of  
 us Alfred Long, John Lee & Thomas Long   
 South Carolina & Personally came John Lee before me an  
 Greenville District & acting Justice for sd. District and made  
 oath and saith that he saw Thomas Long sen. assign and deliver  
 The within deed of conveyance to Isaac Cox for the use and purpose  
 Within mentioned and that he also saw the subscribing witness with him  
 self witness the same sworn to before me this 5<sup>th</sup> day of July 1824
