 Tygar River & the Branches of pack's Creek Beginning at a Red Oak  
 Corner joining Brysells Land Running S. 5 W. 38.50 to a red oak  
 Dead, thence N. 80. E 35.50 to pointers thence S. 11 E 21.80. to Red oak on  
 West line thence along West line N. 69. E 37. to a post oak, thence  
 N. 5. W. 6.50 to a chestnut thence N. 34. E 64.25 along Runnels Dills  
 line to a post oak on Stephen Dills line thence N. 9. 20. to a Red o.  
 Thence N. 70 E 12: 30 to a stake and pointer thence N. 48. 37 join-  
 ing Dills Land to a small white oak joining Centers Land Running  
 N. 69. W 58.50 to a Red oak thence along Adamses Land S. 57. to a
