 S. 55 W. 60 to a rock, thence S. 72. 27 to a Chestnut, Oak, thence a straight  
 line to a Branch the head of Maddox mill Creek, concluding the Bra-  
 nch to be the line on to below line thence along that line to the begin-  
 ning corner containing one hundred acres more or less together with  
 all & singular the rights, members, & appurtenances <sup>to the said premises</sup>
