County of the other part witnesseth that for and in consideration of the sum  
of fifty pounds Lawful Sterling money to the S<sup>t</sup>. William Cox Junr. in hand  
Well and truly paid at and before the sealing of these presents by S<sup>t</sup>. Jeze Sparkes  
the receipt whereof the S<sup>t</sup>. William Cox Junr. doth here by acknowledge and  
thereof from Every part an parcel do a quit and discharge the S<sup>t</sup>. Jeze  
Sparkes his heir, and assigns and for divers others good causes and consid-  
eration, here unto Moring have granted Bargained sold aliened Enfeoff-  
and confirmed and by these presents do grant Bargained sold all Enfeoff-  
and confirm unto the S<sup>t</sup>. Jeze Sparkes his, heir, and assigns for Ever a cer-  
tain plantation or tract of Land situated in Ninety six District and Cou-  
nty of Greenville on both sides of a Branch of the Reedy fork of Reedy  
River Containing two hundred acres, (more or less) being a tract of land  
Granted to Will<sup>l</sup> Miller and sign'd by his Excellency William Moultrie  
on the second day of October one thousand seven hundred and Eighty  
Six as by the planers, to the grante will appear laid out to the S<sup>t</sup>. Jeze  
Sparkes as follows Beginning on the original line on a hickory corner, on  
Paley Prince line thence N 70 W 100 to a Spanish oak thence N. 20 E 20. 10. a.  
Redoak, N 70. E 100 to a Red oak thence S. 20 W 20. to the begining corner toget-  
her, with all and singular the houses out houses, ways, water, paths, parap-  
-er trees, fences, Earments, Headiments and appertaining whatsoever to  
the S<sup>t</sup>. parcel or tract of land above described Belonging or in any wise  
appertaining and the Reversion and Revertions, Remainder and Rem-  
ainders, Rents, Dues and worthies ther. of and Every part and parcel  
thereof an all the Estate Right titl interest claime and demand-  
es whatsoever Both in law and Equity of the S<sup>t</sup>. William Sparkes of  
in and to the same premises and of in and Every part and parcel  
thereof to have and to hold the said tract of land as above described  
and all and singular, other premises above mentioned with the  
appurtenances unto the S<sup>t</sup>. Jeze Sparkes his heirs and assigns to  
the only proper use and behoof of him the S<sup>t</sup>. Jeze Sparkes his heir  
and assigns for Ever and Lastly the S<sup>t</sup>. William Cox Junr. for him  
self his heirs and assigns the S<sup>t</sup>. tract or parcel of land and all an-  
d singular the premises above mentioned and granted with the  
appurtenances unto the S<sup>t</sup>. Jeze Sparkes and his heir, from the  
lawful claim of all persons whatsoever will warrant and forever
