State of South Carolina Know all men by these presents that I Stephen Howard of Greenville District and State aforesaid in consideration of one hundred and twenty dollars to me paid by John Baldwin of the District and State aforesaid have bargained sold and released and By these presents do bargain sell and release unto the said John Baldwin all that tract or parcel of land lying in the District of aforesaid on the south side of the Horsepen Creek beginning at a gum corner on said Creek and running S.33 W. to a white oak corner & thence in a line to a long said Jenkins line to a Spanish oak & thence East to a black oak & thence N.40 W. 13. 50 to a pine corner & thence N. 50 E. to a Spanish oak & thence N. 49 W. 53. 50 to the Beginning containing one hundred & twenty three acres be the same more or less together with all and singular the rights members hereditaments &c to the said premises belonging or in any wise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said John Baldwin his heirs & assigns forever and I do hereby bind myself my heirs Executors & Administrators to warrant and forever defend all and singular the premises before mentioned unto the said John Baldwin His heirs & assigns against myself my heirs & against every other person whomsoever lawfully claiming or to claim the same or any part thereof of Witness my hand and seal the 30 day of Sept in the year of our Lord One thousand eight hundred & twenty and in the 45th year of the independence of the United States of America.
