


side of Reedy River being part of a tract of two hundred and twenty three
Acres Originally granted to Hugh Roark and signed by Governor Moul-
trie on the sixth day of June one thousand seven hundred & eighty five as
By reference to the Original plat & Grant well fully appear
Situate in the District of aforesaid on Reedy River near the said fifty
acres of Land more or less is laid out unto the said Benjamin
Dunn as follows beginning at a Stake corner on the Original
Line & running S. E. 50 to the middle of Reedy River thence running
up the middle of R. River until it intersects with Matthew
Armstrongs line thence running westwardly on Armstrongs line
to the Original line thence running S. E. 41 to the beginning including
fifty acres of Land more or less together with all & singular the rights
members hereditaments and appurtenances to the sd. premises belonging owned
anywise incident or appertaining to have & to hold all and singular
the premises before mentioned unto the sd. B. Dunn his heirs & assigns
for ever & I do hereby bind myself my heirs Executors and administrators
