E. 22. 25 to a pine Stump near the house thence N. 41. 10. 12. 25 to a Red oak Stump on the Road thence By the Road S. 40. 10. 24. 58 to a pine corner thence to the beginning to have & to hold the premises above described together with all and singular the Rights members hereditaments and appertinances to the said premises belonging incident or appertaining to the said Rutledge his heirs or assigns for ever against myself my heirs or assigns and all other persons whomsoever claiming the same or any part thereof in witness whereof I have hereunto set my hand & affixed my seal this third Day of Sept 1824 signed sealed & delivered in presence of
