





The State of South Carolina Know all men by these Presents, that we Nancy Brady widow and William Brady of Granville district in the State, in consideration of the sum of Twenty five dollars, to us paid by Baylis J. Earle of the same district in the State aforesaid have granted bargained, sold and Released, and by these presents do Grant bargain sell and Release unto the said Baylis J. Earle all that plantation or Tract of Land situate in the district aforesaid on the waters of Broad river on both sides of the main road from Granville C.H. to the Saluda Gap; whereon the said Nancy now resides, having the following lines and course, viz. Beginning in Hickory W. Carrolls corner, thence down the Middle of Hollow to the Spring, thence down the spring branch to a small creek, thence down the Creek to the original line of the said tract; thence with the said line to a conditional corner made by and between William Brady dec<sup>d</sup> and William Sutton, thence a straight line to a corner near Bains, old calf pasture, thence along Suttons line to a white oak corner near a Spring thence with James Burys line to the old road from Rays to Bains, thence along said road to the beginning containing One Hundred and fifty Aers, more or less, Together with all and Singular, the Rights, Inheritance, and Appurtenances, to the said premises belonging or in anywise incident or appurtenant, to have and to hold all and Singular the premises before mentioned, unto the said Baylis J. Earle his heirs and assigns, forever. - And we do hereby bind ourselves our heirs Executors & Administrators, To Warrant and forever defend all and Singular the said premises unto the said Baylis J. Earle his heirs and assigns, against us and our heirs and against every other person or persons whomsoever Lawfully claiming or to claim the same or any part thereof.
