 -mises beloning or in any wise incident or appurtening to have
 and to hold all and singular the premises before mentioned unto the
 said Hiram Cooley his heirs Executors administrators and assigns for ever and
 I do hereby bind myself my heirs Executors and administrators to warrant
 and for ever defend all and singular the said premises before mentioned
 against my self and my heirs and every other person or persons whom
 some lawfully claiming or to claim the same or any part thereof in
 Witness whereof I have hereunto set my hand and seal in the year of
 our Lord 1826. and now the 29 day signed sealed and delivered
