Know all men by these presents that I Tucker Woodson of the State and district aforesaid in consideration of the sum of Four hundred dollars to me in hand paid by Hiram Cooley of the same place have granted bargained and sold and by these presents do grant bargain and sell unto the said Hiram Cooley all that plantation or tract of land containing one hundred and forty two & $\frac{1}{2}$ acres more or less originally granted to William Wood on the first day May 1786. being a part of a thousand acre tract lying and being in the State and district aforesaid on Mountain Creek beginning on a B. o. 3 x thence S. 87 E. 16. 75. to a Stake 3 x thence S. 9. E. 52 00 to Hickory 3 x thence S. 60. W. 34. 80 to Stake 3 x thence N. 4. E. 70. Ch. to the beginning corner. Together with all and singular the rights, members, hereditaments and appurtenances to the premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Hiram Cooley his heirs Executors administrators and assigns for ever and I do hereby bind myself my heirs Executors and administrators, to warrant and forever defend all and singular the said premises before mentioned against my self and my heirs and every other person or persons whom sooner lawfully claiming or to claim the same or any part thereof in witness whereof I have hereunto set my hand and seal in the year of our Lord 1826. and Nov. the 29. day signed sealed and delivered in the presence of John Armstrong *J.D.* Isaac Jordan ^{mark}, James Backum *J.D.* Tucker Woodson *Seal*
