E. 24. to a stake 37. thence S. 55. E. 37. to a red oak 37. bounded on Arnold's land thence S. 47. W. 40. to a stake 37. bounded on L. Allen land thence N. 43. E. 24. to a maple 37. bound on Shadrack Jamesons land and from thence to the beginning To have and to hold all and singular the premises before mentioned unto the said Benjamin Arnold his heirs and assigns for ever and I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the premises before mentioned unto the said Benjamin Arnold his heirs and assigns against myself and my heirs and against every other person or persons whomsoever lawfully Claiming or to Claim the same or any part thereof Witness my hand and seal this the ninth day of September in the year of our Lord one thousand Eight hundred and twenty five for Joseph Sullivan, Pleasant Shaw, Henry Bureau
