Panders corner on the bank of the River thence with his line N. 85. W. 27. 50 to a black oak thence S. 75. W. 24. to a pine knot thence N. 42. E. 11. 50 to a red oak thence N. 8. E. 18. to a red oak thence N. 68. E. to a stake thence E. 24. Ch to an oak on the bank of the River thence down the meanders of the River to the beginning containing by estimation one hundred and thirty nine acres be the same more or less together with all and singular the rights members incidents and appurtenances to the said premises belonging or in any wise incident or appertaining to have & to hold all and singular the premises before mentioned unto the said Campbell his heirs & assigns forever and I do hereby bind my self my heirs Executors and administrators to warrant and for ever defend all & singular the said premises unto the said Thos Campbell his heirs and assigns against my self & my heirs and against every person whosoever lawfully claiming or to claim the same or any part thereof.
