This Indenture, made the twenty fifth day of June in the year of our Lord, One thousand eight hundred and Twenty seven between Nimrod Underwood of the one part, and Thomas Benson, John Hodges, John Young, Wheaton Merritt, George Russell — Aquilla Bradley and Alexander Waddill of the other part witnesseth Whereas, the said Nimrod Underwood has been Elected & Serving as Sheriff of Grenville district and the other persons named as a bove of the second part are his Secuties on his Bond for the performance of his duties of office, and have in that character paid a large sum of money for said Underwood for which as Sheriff he was liable to the sum of Thirteen hundred dollars and whereas in all probability they may be compelled to pay other large sum for him. Now this indenture witnesseth, that the said Nimrod Underwood for and in Consideration of the said debt, or sum paid as aforesaid for the said Underwood and of the said liability to pay other and further sums. And for the better securing the payment thereof, to the said Secuties and indemnifying them against the same and all future losses the said liabilities on their said Bond and also in Consideration of the sum of one dollar to the said Nimrod Underwood by them the said persons of the second part in hand paid at and before the sealing and delivery of these presents, do grant, bargain, sell, alien, release convey and confirm unto the said Thomas Benson, John Young, John Hodges Wheaton Merritt, George Russell A.D. Bradley & A. Waddill and to their heirs and assigns for ever, all that tract of Land containing Two hundred and fifty acres on Rudy River where the said Underwood now lives Conveyed to him by Joshua Hawkins Recorded in Registers off Book R page 93, ~~and~~ ^{and} being such shape Causes distances how adaries as are therein set forth reference being therunto made;
