Together with all and singular the Rights members, hereditaments and appurtenances, to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises herefore mentioned unto the said Edward Croft his heirs and assigns for ever And I the said Pinkney Hawkins do hereby bind myself & my Heirs, Executors and administrators to warrant and for ever defend all and singular the said premises unto the said Edward Croft his heirs and assigns, against myself and my heirs & also against all and every other person & persons lawfully claiming or to claim the same or any part thereof.
