tion Tract or Parcel of Land containing six hundred and twenty eight
Acres, be the same more or less situate in Granville District aforesaid
on the North East side of the North Fork of Saluda River and run-
ning as follows viz. Beginning on a bica more on the bank of said River
at the mouth of an old ditch thence N. fifty six degrees E. twenty nine
Chains to a poplar at the mouth of a ditch cut by Britton thence N.
twenty one degrees E. eighteen Chains to a Chestnut on a branch thence up
the straight fork thereof to the first fork below a school House thence
up the left fork of said branch to a marked white oak and stake a cross
the Road thence N. thirty three degrees W. Twenty Chains to Rodins Red
Oak corner thence the same course thirty three Chains to Rodins Spanish oak
