 thence northwardly up the hill to a chestnut & thence along the  
 ridge to May's branch to a white oak corner thence down said  
 branch to the beginning same being a part of a tract of land  
 granted to Robert Prince which parcel of land together with  
 all and singular the premises before mentioned unto the heirs &  
 love mentioned & their heirs and assigns for ever to have and  
 to hold the premises above mentioned to sd Wm Burns, Isaac  
 John & William their heirs and assigns and I do for myself my  
 heirs Executors & administrators to warrant & for ever defend the  
 premises above mentioned to the sd heirs & their heirs Executors  
 & administrators or assigns against myself my Executors admin-  
 -istrators & against every other person or persons whomsoever law-  
 -fully claiming or to claim the same or any part thereof witness  
 whereof I have hereunto set my hand & seal this 3<sup>d</sup> day of October
