 ters of Enoree River it being a tract of land originally granted  
 to the said Nathan Berry for three hundred and fifty three acres  
 granted the third day of Sept-1821 recorded in grant book N.  
 Volum 64. beginning on a Chertnut 3x thence running N. 60 W. 42 to a B.  
 P. 3x thence N. 20 E. 70 to a B. Gum 3x thence S. 70. E. 25.50 to a Chertnut 3x  
 thence S. 55. E. 28.50 to a Stake 3x thence S. 30 W. 71. to the beginning contain-  
 ing three hundred and fifty three acres be the same more or  
 less Together with all and singular the Rights members hereditam-  
 ent and appurtenances to the said premises be lanning or in any  
 wise incident or appertaining to have and to hold all and  
 singular the premises a here mentioned unto the said Gran  
 P. Pool his heirs and assigns for ever and I do hereby bind my  
 self, my heirs Executors and administrators to warrant and four-  
 defend all and singular the said premises unto the said  
 Gran P. Pool his heirs and assigns for ever against myself  
 and my heirs and no further a making to the said Pool such  
 a right as the State made to me. Witness my hand and  
 seal this third day of 3<sup>rd</sup> April in the year of our Lord  
 one thousand eight... and twenty seven and in the  
 fifty first year of the Independence of the United States  
 of America signed seal and acknowledged and deli-  
 vered in the presence of
