 of the State of S. Carolina and Greenville district of the one part and  
 Ralph Johnson of the State and district aforesaid of the other part  
 witnesseth that for and in consideration of the sum of one hundred dol-  
 -lars to him in hand paid by the said Ralph Johnson the receipt of  
 whereof is hereby fully acknowledged hath bargained sold and  
 delivered and by these presents doth bargain sell and deliver unto  
 the Ralph Johnson his heirs and assigns for ever a certain tract or  
 parcel of land situate lying and being on the head of fountainburg  
 fork of Tyger River being part of a tract of land surveyed from  
 James Dawson dated not known then decided by said Dawson  
 to Joseph King the 5 day of September 1807. having such bounds  
 and marks as are hereby represented to the plat. Beginning on a post  
 oak running S. 18. W. 30 and 80 links to a stake thence W. 5. chains to a  
 hickory thence N. 36. W. 31 chains and 50 links to a Spanish oak  
 thence N. 70. E. 17. to --- thence N. 95. 18. and 50 links to a hickory thence  
 thence E. 15. to a elm nut. thence S. 10. E. 2. 1 links to beginning corner  
 containing of 123 1/2 together with all and singular the rights and  
 premises to same belonging or in any wise appertaining to be one  
 and to hold all and singular the said premises to the proper use  
 and behoof of him the said Ralph Johnson his heirs and assigns  
 shall and will warrant and for ever defend from my self my
