Lann containing one hundred & seventy five acres more or less situated in the district & State aforesaid on a branch of Brasley Creek water of Enore River beginning on a R. 03+ on Joseph Woodall original line & run with sd line S 65. E 9.50 to P. 03+ thence S 80. E 9.50 to a R. 03+ thence S 12. E 14. to R. 05+ thence N 80 E 23 to a Hickory 3+ thence S 50 E 15.75 to a Hickory 3+ thence N 12. W. 12.25 to a St. 3+ thence N 3. W. 28. Chain to a R. 03+ on Haven line then with sd line N 60 W. 44 to a St. 3+ thence S 19 W. 39 to the beginning corner which bounds contains the land to be conveyed together with all and singular the rights members hereditaments and appurtenances thereto belonging or in any wise incident or appertaining. To Have and to hold and singular the above described premises unto the said Zachariah Smith his heirs & assigns for ever I do hereby bind myself my heirs Exrs & administrators to warrant and ever defend the above described premises unto the said Zachariah Smith his heirs & assigns against myself my heirs Exrs & adms. and against every other person or persons lawfully claiming or to claim the same or any part thereof with my hand and seal this 24 February A.D one thousand and eight hundred & twenty five and in the forty ninth year of American Independence—
