 -land and Samuel Brayton as Trustees conveyed a negro girl in trust  
 named Rosena who it is said and believed by us was and is ~~found~~ in  
 her mind by which she is rendered of much less value therefore with a  
 view to dispose of her and procure a more valuable slave we all agree  
 and confirm the Exchange made by the said Benjamin Allston of the said  
 Rosena for a nother girl called Minney between where the said Benjamin  
 Allston paid One hundred and twenty five dollars and substitutes  
 the said Minney not named in the original deed in place of the said  
 Rosena therein named and we unanimously being of opinion that  
 this arrangement and Exchange is greatly for the benefit of every  
 Trustee and we accordingly agree and accede to it fully -  
 Witness our hands and seals this third day of September A.D. 1828.

 -ton of Georgetown Planter and Martha Hays Pyatt also of  
 Georgetown willow by their deed in writing dated the fiften  
 -th day of December in the year of our Lord one thousand  
 eight hundred and twenty seven conveyed to us six negro  
 slaves to hold in trust for William Mauldin and Martha  
 Lavinia Judica his wife agreeably to the terms of that  
 deed and with a view to promote and advance the  
 interest of the said William Mauldin and his wife we  
 have returned the negro girl named Rosena in the said  
 deed of Trust to the said Benjamin Allston and Martha
