 these presents that Joshua Hawkins of the District of Greenville in the State of
 South Carolina for and in consideration of the sum of six hundred and twenty dollars
 to me paid by William Smith Barnett and David Hennings of the same place
 first above mentioned have granted bargained sold and released and do by
 these presents grant bargain sell and release unto the said William Smith Barnett and
 David Hennings the several pieces, tracts or parcels of land that is to say. All that
 piece, parcel or tract of land conveyed to me by James H. Gillette by deed bearing
 date 14 day of August 1824 and recorded in the clerks office of Greenville
 District in Book N page 328. Beginning at a post oak at the wagon road
 thence westwardly a conditional line on Noel Waddells line to a red oak then
 S. on James Barnes line to a sweet gum on a branch thence down the
 meanders of the branch to the mouth, thence up the meander of Mountain creek to a poplar
 on the wagon road thence N. a long said road to the beginning supposed to contain
~~two hundred acres be the same more or less~~^{to be the same more or less}, also one other piece parcel or tract of
 land adjoining the said tract above mentioned and described being a part
 of the tract granted to James Barnes and from him to me by deed a refer-
 ence to the clerks office will more fully show beginning on Noel Waddells
 red oak 3x. thence an Joseph Chandler line to a poplar on the long
 branch thence up the meanders of said branch westwardly to a chestnut
 3x thence S. a straight line to a pine stump 3x thence Robert Hawkins
 line to a sweet gum mentioned in the first tract supposed to con-
 tain One hundred acres be the same more or less together with all
 and singular the rights, members, hereditaments and appurtenances
 to the said premises belonging or in any wise incident or appertain-
 ing to have and to hold the said several premises unto the said
 William Smith Barnett and David Hennings their heirs and assigns
 Executors administrators or assigns from me and my heirs Executors
 administrators or assigns or any other person or persons whomsoever
 lawfully claiming or to claim the same or any part thereof. In witness
 whereof I have hereunto set my hand and seal this 21 day of
 December A.D 1830. signed sealed and delivered in the

 thereof sworn to this 10 day of January A.D 1831.
