to be paid by the said James Bennie the receipt and payment whereof  
I do hereby acknowledge have granted bargained and sold and by  
these presents do grant bargain and sell unto the said James Bennie  
his heirs and assigns for ever the said tract parcel of Land with its appurten-  
ances and all the Estate right title and interest which the said David  
Barnett of Right had of in and to the same to have and to Hold the  
said ~~piece~~ parcel and tract of Land with its appurtenances unto  
the said James Bennie his heirs and assigns for ever as fully and  
absolutely as I the said James McDaniel Sheriff might could or  
ought to grant bargain and sell by virtue of the Statute aforesaid
