

South Carolina Know all men by these presents that I Joshua Thompson of the district and State a have written for and in consideration of the sum of Two hundred dollars to me in hand paid by Laurence Lenhart of the State and district aforesaid the receipt whereof I do hereby acknowledge Have bargained and sold and by these presents do grant bargain sell release convey and confirm unto the sd Laurence Lenhart & his heirs and assigns a certain tract or parcel of land lying on a small branch of the Golden Grove of Saluda River which sd tract is laid out to the sd Lenhart as follows viz Beginning at a white oak ^{XXX} on a branch running S. 9° E 19 chains & 50 links to a Dogwood ^{XXX} on M. Halls line thence S. 70. W. 34. Chains to a Stone ^{XXX} on Judge Gantt thence North 28 chains to a small hickory ^{XXX} originally a State on Judge Gantt thence west one chain to a Huckleberry on a small branch thence up the meanderings of sd branch to a small maple ^{XXX} thence N. 21. E 1 chain and 28 links to a Spanish Oak ^{XXX} thence S. 81. ° E 4 chains & 90 links to a Stake ^{XXX} thence N. 45. ° E 24 chains to a post oak on W. Benson ^{XXX} thence S. 20. chains & 40 links to a Stake ^{XXX} thence East 8 chains to a Stone ^{XXX} thence S. 75.
