 to a red oak corner. thence with said Evans line to the Beginning corner
 Together with all & singular the rights, members, Hereditaments and
 appertinances to the s^d. premises belonging or in any wise incident or
 appertaining to have & to hold all and singular the premises before
 mentioned unto the said Reuben Martin his heirs & assigns for ever
 and I do hereby bind my self, my heirs, Executors & administrators to war-
 rant and forever defend all and singular the said premises unto the
 said Reuben Martin his heirs and assigns against my self my heirs and
 against Every other person or persons whomsoever lawfully claiming
 the same or any part thereof as witness my hand and seal this

 bank of Gilders creek and running N. 8 W. 35. 12 to a white oak x 3 thence down
 the various courses of said creek to a stake x 3 thence N. 55 E. 2. 50 to a black oak
 x 3 thence S. 20 E. 12. 50 to a pine x 3 thence S. 8. 8. 35 to a Spanish Oak x 3 S. 82. W. 13. 30 to the
 beginning including also all the land that was granted to said James Powell on
 the North side of Gilders creek it being all that Land that was reserved by said
 Powell for a mill seat including one hundred and twenty five acres more or less
